



# The Governor's Fund: \$934,765,676.90 Under Cox's Personal Control

On August 20, 2021, via recorded call, the Governor's Fund manager confirmed that **Cox personally controlled the entire \$934,765,676.90 in federal CARES Act funds**. This unprecedented concentration of financial power enabled Cox to:

# The CentraCom Conflict: \$125 Million Family Enrichment

#### **Cox's most egregious conflict of interest:**


- \$125,000,000 grant to Utah Education Telehealth Network (UETN)—the largest individual disbursement from the Governor's Fund

# **Federal Audit Findings: \$47.1 Million in Questioned Costs**

The Treasury Office of Inspector General found **\$47,161,537** in questioned costs from Utah's CARES Act spending, with **\$40,308,738** unsupported and **\$6,852,799** ineligible—validating allegations of systematic misuse under Cox's control.




